1 SCOPE

This specification defines the minimum technical requirements for design, engineering, manufacture, testing, inspection and performance of pole-mounted metering unit rated up to 36kV for outdoor installation intended to be used for the measurement of energy consumption of bulk customers fed directly from medium-voltage overhead lines. This unit shall be mounted on an H-frame pole structure.

4 SERVICE AND SYSTEM CONDITIONS

The pole-mounted metering unit shall be suitable for operation under the service conditions specified in the latest revision of SEC specification 01-SDMS-01.

All components, fittings and attachments of the unit shall be capable of withstanding the effects of direct solar radiation at their installed locations. The temperature of surfaces exposed to direct solar radiation shall be regarded as 75°C plus the effect of any internal heating.

5 MATERIAL, DESIGN AND CONSTRUCTION REQUIREMENTS

5.1. GENERAL

- 5.1.1. The pole-mounted metering unit shall be air-insulated, self-contained, factory assembled in a totally enclosing aesthetically acceptable cladding. General components and layout shall be as shown in the drawings.
- 5.1.2. The pole-mounted metering unit shall consist, but not limited to the following major components:
 - 5.1.2.1. Enclosure
 - 5.1.2.2. Current Transformers
 - 5.1.2.3. Voltage Transformers

- 5.1.2.4. High-Voltage Fuses
- 5.1.2.5. High-Voltage Bushings (Polymeric Type)
- 5.1.2.6. Instrument Wirings
- 5.1.3. The insulation levels of each of the component of the pole-mounted metering unit shall be coordinated with the insulation level of the whole unit applicable for its intended voltage level.

5.2. ENCLOSURE

THE ENCLOSURE SHALL BE DESIGNED AS FOLLOWS:


Figure 1: General Features of Pole-Mounted Metering Unit

- 5.2.1 The enclosure shall be made of galvanized steel sheet with minimum thickness of 3.0mm or of Aluzinc steel sheet at least 2.0mm thick, the shape and dimensions are as shown in Figure 1 and Figure 2.
- 5.2.2 The enclosure shall be outdoor type with minimum degree of protection of IP54.
- 5.2.3 The enclosure shall have adequate mechanical strength to withstand rough handling as may be expected in normal uses.
- 5.2.4 Adequate ventilation shall be provided on the enclosure by means of breathable canopy and/or louvers to allow natural circulation of air. Ventilation shall be screened to prevent the entry of insects, vermin, and other foreign bodies. The screening material shall be rigid and strong made of stainless steel.
- 5.2.5 The enclosure shall be suitable to be installed on a fabricated steel skid base made of U-Channel 100mm x 50mm. The unit shall be supplied with complete set of hot-dipped galvanized Grade 8.8 mounting fasteners (bolts, nuts, washers, etc.)
- 5.2.6 Access shall be from the front by means of twin-door with gaskets and concealed stainless steel hinges duly welded. Each door shall be provided with three stainless steel hinges. The hinges shall have removable pins, to render it possible to remove the doors, if necessary.
- 5.2.7 Pressure fit type gasket shall be provided. Glue fit type is not acceptable.
- 5.2.8 The doors shall be provided with door stoppers and locking at open position up to 120° to prevent it from swinging.
- 5.2.9 Door security and locking provisions shall be as shown in Figure 1.
- 5.2.10 The enclosure shall be fitted with lifting lugs on both sides at the top, and suitably located to ensure that the complete unit is balanced when lifted.

- 5.2.11 The enclosure shall be provided with surge arrester mounting brackets both on the incomer and outgoing side, respectively. The sizes of the surge arrester mounting holes are Ø14mm.
- 5.2.12 Two grounding terminals having M12 stainless steel stud and nut shall be provided and shall be clearly identified by a grounding mark. The grounding studs are internally connected on the earthing busbar by 35mm² tin-coated braided copper wire-links with terminal lugs on both ends.
- 5.2.13 Pocket for wiring diagrams, approved fabrication drawings, test reports, component details, and leaflets shall be fixed internally on the back-panel of left-side door.
- 5.2.14 SEC monogram and danger sign plate MV equipment, respectively in accordance with SEC-01-01 and Figure 49 of 20-SDMS-02, shall be provided on the front-panel of each door.
- 5.2.15 Indications of the power flow (INCOMING/OUTGOING) shall be marked legibly or engraved on a metallic plate to be fixed permanently near the bushings and are clearly visible from the ground-level.
- 5.2.16 The enclosure shall be adequately protected against corrosion and painted in accordance with the requirements of latest revision of SEC specification 01-SDMS-01. Paint color shall be RAL 7035.

5.3 CURRENT TRANSFORMERS

- 5.3.1 Two dual-ratio CTs encapsulated-type shall be provided. It shall be well-fixed on the red and blue phases.
- 5.3.2 CTs shall conform to IEC 61869-1 and IEC 61869-2, and meet the applicable requirements of the latest revision of SEC specification 50-SDMS-01.

5.4 VOLTAGE TRANSFORMERS

- 5.4.1 Two VTs encapsulated-type shall be provided.
- 5.4.2 The VTs shall be protected on the HV-side by a 6.0 ampere HV-fuses.
- 5.4.3 VTs shall conform to IEC 61869-1 and IEC 61869-3.





Figure 3: Circuit Diagram of Pole-Mounted Metering Unit

- 5.4.4 The secondary terminals of the VT circuit as shown in Figure 3 shall be connected on three low-voltage miniature circuit breakers located at the wire termination box.

5.5 HIGH-VOLTAGE FUSES

5.5.1 Two HV-fuses rated 6.0A with striker (indicating device) shall be provided. Dimensions are as shown in Figure 4.

A suitable indicating mechanism clearly visible from the ground-level shall be mounted on the bottom part of the pole-mounted metering unit indicating that at least one of the fuses had blown-out. This mechanism will be activated by the striker pin of the fuse that is either mechanically or electrically linked to a flag. Alternative solution for this requirement may be proposed and subject for SEC evaluation and approval.

The mechanical flag shall be colored stripes of yellow and black.

5.5.2 The high-voltage fuses shall conform to IEC 60282-1.

5.6 HIGH-VOLTAGE BUSHINGS

The pole-mounted metering unit shall be provided with two sets of roof-mounted, outdoor-type, polymeric high-voltage bushings for terminations of the incoming and outgoing conductors. The minimum requirements of the bushings are as follows:

- 5.7.1 Internal wirings of the pole-mounted metering unit shall be 2.5mm² single-wire solid-core copper with black PVC insulation designed for a maximum permissible continuous temperature of 90°C.
- 5.7.2 The wires shall be laid in ducts or ties from the CTs and VTs and connected on the terminal blocks located at the wire termination box. The CT and VT wires shall be tagged with ferrules, i.e. reference terminal block name/number.
- 5.7.3 The wire termination box shall house all the terminal blocks, shorting provisions, and MCBs. It shall be weatherproof sealable metallic box fixed on the lower part of the pole-mounted metering unit as shown in Figure 1.

Locking provision shall be provided to limit access on the wirings to authorized personnel only.

Cable clamps shall also be provided under this termination box to secure and hold the pilot cables.

One opening on the bottom plate of the termination box shall be provided for the entry of the pilot cable. This hole shall be provided with rubber bushing/grommet for sealing purposes.

7 TESTING AND INSPECTION

The pole-mounted metering unit shall be inspected and tested in conformance with the requirements of applicable standards and SEC specifications.

7.1. ROUTINE TESTS

Routine tests shall be performed on all pole-mounted metering units. Electronic copies of the test reports shall be submitted to SEC in USB thumb drive for each batch to be delivered prior to issuance of the releases.

SEC reserves the right to witness the routine tests on all units or on randomly selected samples thereof.

7.2. Type tests

Each major component of the pole-mounted metering unit shall be type tested, i.e. HV-bushings, CTs, VTs, Fuse System (fuse and fuse-base).

Type test for the whole pole-mounted metering units shall include but not limited to the following tests:

- a. Short-Circuit Current Withstand Test
- b. Power Frequency Withstand Voltage Test
- c. Lightning Impulse Test
- d. Temperature-Rise Test
- e. Degree of Protection Provided by Enclosures (IP Code)
- f. Salt Spray Test and Tape (Scratch) Test

Type test shall be performed in complete conformance with the applicable standards. It shall be performed at SEC approved laboratories.

SEC reserves the right to attend and witness the tests.

SEC reserves the right to request the supplier/manufacturer to repeat the type test every five (5) years, or as needed should the supplied units have frequent faults and failures.

7.3. SAMPLE INSPECTION

Samples together with actual/approved CAD drawings and routine test reports shall be inspected prior to issuance of approval for mass production. The following attributes shall be checked:


