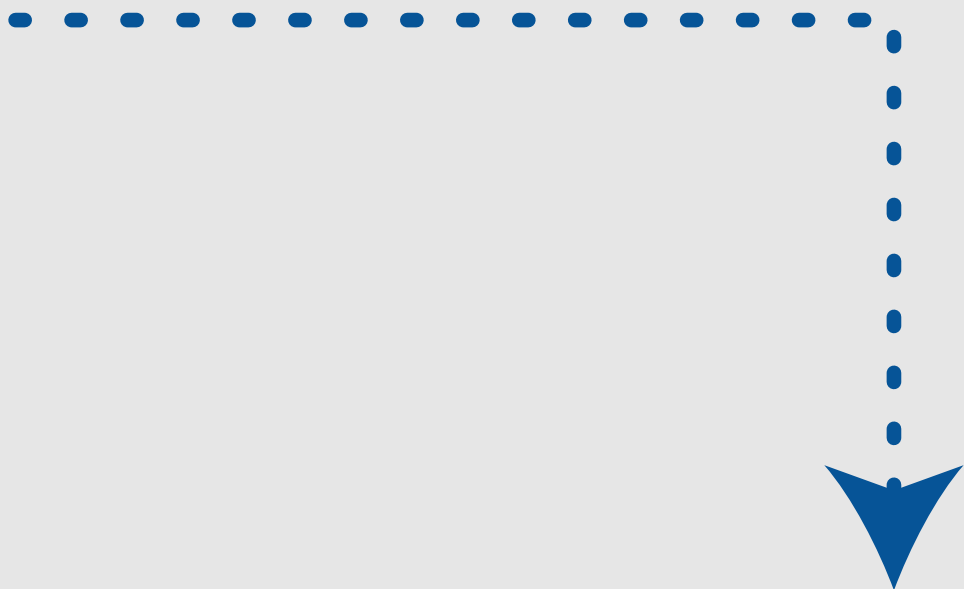
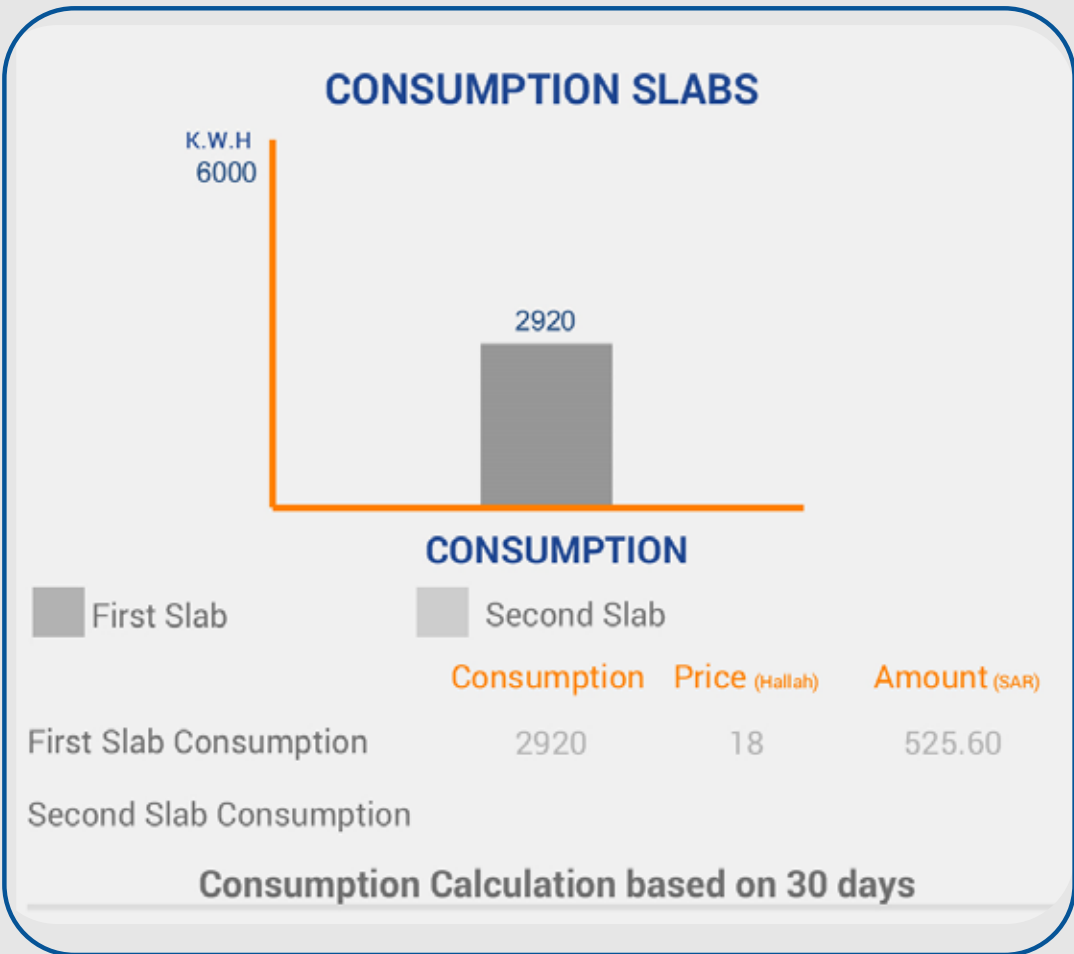
Service Category

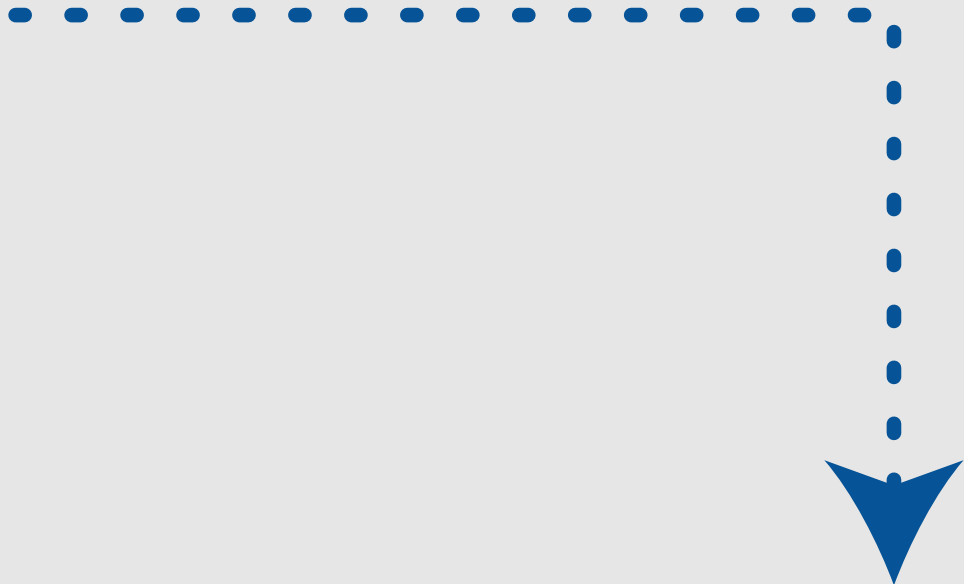
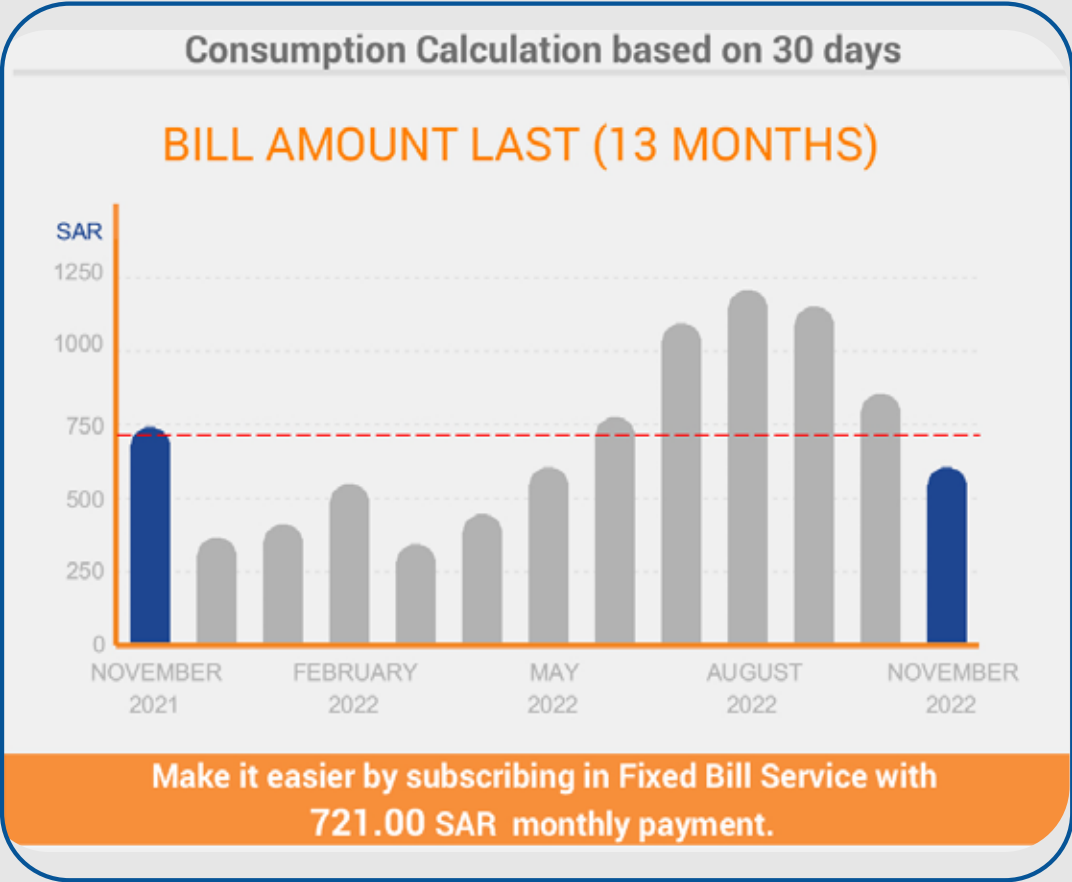

Financial Statements

- help you to know:
- **Consumption value:** The total amount for the last invoice consumption "excluding other items".
 - **Meter Service:** Meter Service Fee "varies based on breaker capacity".
 - **Taxable Amount:** The total taxable amount "Meter Service Charge Included".
 - **The amount includes VAT:** This is the taxable amount plus 15%.
 - **Former Balance:** It is the outstanding accumulated amount.
 - **Total Invoice:** This is the total amount inclusive of tax and the outstanding balance.

Technical Data of the Meter

- include:
- **Meter number:** It is the serial number of the meter.
 - **Subscription number:** It is the external number of the meter.
 - **Reading Period Start:** It is the date of the previous reading taken from the counter.
 - **End-of-period Reading:** It is the last reading taken from the meter and the amount of consumption that is calculated based on it.
 - Amount of consumption = (Period End Reading – Period Start Reading) * Multiplication coefficient
